## 5. Secretary's Report

## 5.1 Public Sector

The Secretary reported that the public sector agreement was finally ready to be voted on. Meetings to conduct the voting would commence as of the week beginning March 10 2003.

#### 5.2 Disability Sector

The Secretary reported that the full bench of the Australian Industrial Relations Commission has

finally handed down its decision on the Union's claim for non-government disability/early intervention workers. The AIRC has created an interim award to the end of August this year, but granted only the Victorian Government's wage offer for the interim period.

Although the AIRC found that the work of a DHS and NGO workers was essentially identical, it failed to deliver wage justice. Even after hearing uncontested evidence, the AIRC has dropped the ball allowing the continued exploitation of workers and clients in this sector.

# 5.3 Peter MacCallum Cancer Institute

The Secretary reported that PMCC has been underpaying research technology staff since at least 1999, but possibly from 1993. PMCC has also breached the Award and subsequent enterprise agreements. The have failed to provide ADOs, incremental increases, higher qualification allowance, and have fostered an anti union environment.

#### 5.5 Communications

The Secretary reported that she was having discussion with a company called "Shannon's Way" to look at communication strategies for the union. We want them to look at name, logo, publicity material ie posters etc. Further reports will be provided to BCOM.
