




Re: Jeff Jackson

We refer to our correspondence of 31 August 1995 and we now advise as follows.

Our client is prepared to give undertakings that he will not pursue the question of his removal from the office of Assistant Secretary in consideration of the union making to our client a payment representing the salary our client would have earned had he continued in office of Assistant Secretary for the remainder of his current term together with superannuation contributions. In addition that our client be provided with a motor vehicle and that the HSUA take all necessary steps to transfer title of the motor vehicle from the HSUA to our client.

We are instructed that the position of Assistant Secretary was due to be the subject of an election in mid 1996 and that in the event that our client was not the successful candidate he would nevertheless remain in office until the annual general meeting of the HSUA.
